**PETITION FOR ORDER APPROVING
FINAL SETTLEMENT AND
DISTRIBUTION AND
DETERMINATION OF HEIRS**

PETITIONER, Larry Rose, as Personal Representative of the estate of the above-named decedent represents to the Court that:

1. The time for presenting claims which arose prior to the death of the decedent has expired.
2. Petitioner has fully administered the estate of the decedent by collecting and managing the assets of the estate, preparing an inventory of property owned by the decedent at the date of death of the decedent, making payment, settlement, or other disposition of all lawful claims against the estate, and performing all other acts required of petitioner by the laws of the State of Idaho pertaining to estates of decedents.
3. Final Accounting: Petitioner has filed herewith the final accounting.
4. Testacy status. The decedent died intestate. The Court has previously formally appointed petitioner as personal representative of the estate of the decedent. A determination of heirs is requested.
5. Idaho Estate Taxes: The estate is not required to file a federal estate tax return; that no

Idaho estate tax is due and owing under the Estate and Transfer Tax Reform Act of 1988, I.C. 14-401 et seq.; and that the estate is not subject to the restrictions of I.C. 14-411(1).

6. 77 paternal first cousins once removed have been identified. Attached hereto as Schedule A, and incorporated herein, are those 77 paternal first cousins once removed that have been identified. Out of the 77 paternal first cousins once removed, 62 lines of lineage have been followed to identify the living paternal heirs. The remaining 15 paternal first cousins once removed are deceased leaving no issue. Therefore, there are 62 shares to be distributed to 168 paternal heirs. Attached hereto as Schedule B, and incorporated herein, are those 168 individuals identified as paternal heirs. For those deceased paternal heirs identified as receiving 1 share, their 1 share will be split into as many shares as there are surviving issue of the deceased paternal heir.
7. Attached hereto as Schedule C, and incorporated herein, are those individuals identified as maternal heirs. There are 4 shares to be distributed to 6 maternal heirs. For those deceased maternal heirs identified as receiving 1 share, their 1 share will be split into as many shares as there are surviving issue of the deceased maternal heir.
8. Petitioner has filed herewith a Schedule of Distribution which sets forth the distributions to be made. After making final settlement and distribution according to said annexed Schedule of Distribution, petitioner should be discharged as personal representative and his bond should be released and discharged and the administration of this estate should be closed.

WHEREFORE, PETITIONER REQUESTS THAT:

1. The Court fix a time and place for hearing.
2. Notice be given as required by law.
3. After notice and hearing, the Court enter an order:
 - (a) ___ finding that the decedent died intestate and determining the decedent's heirs and their respective interests in the decedent's estate as set forth in the attached Determination of Heirs.
 - (b) ___ Approving the final account of Petitioner filed herewith.
 - (c) ___ Authorizing and directing petitioner to transfer title in the assets of the estate and distribute them to the distributees in the amount and manner set forth in the annexed Schedule of Distribution, approving all prior distributions set forth in the Schedule of Distribution, and after petitioner has made such final settlement and distribution, discharging petitioner and closing the

administration of this estate.

(d)___ Releasing and discharging petitioner's surety bond.

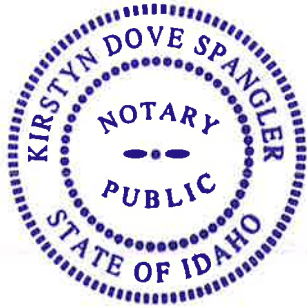
